ENG 12095: Reading & Writing for Academic Success I

Course Description: This course is designed for high intermediate ESL students to promote critical, academic thinking skills and English language proficiency in reading and writing. The course aims to prepare students for success in reading and writing tasks in academic settings.

- **In reading**, students will present ideas and express opinions in a group academic texts as evidence and support. Students will practice different reading strategies to strengthen their reading skills and comprehension and increase their reading speed. Students will build their background knowledge and increase vocabulary. Students will strengthen their note taking and outlining abilities with weekly practice.

- **Reading Learning Outcomes-** Students will be able to:
 1. demonstrate the understanding of the main ideas of longer texts
 2. demonstrate an understanding of inferences and pronoun referents
 3. paraphrase and summarize a reading
 4. critique, respond and analyze an academic reading through writing or oral communication
 5. use a standard note-taking format to record main ideas and details of a reading
 6. increase recognition and use of academic vocabulary
 7. recognize text organizational patterns

- **In writing**, students will write essays that are well developed, organized, grammatically accurate, and cohesive. Students will focus on the development of the main idea, strong supporting ideas and details for body paragraphs, a strong conclusion, organization and cohesion, sentence variety and writing for a specific audience. Students will be introduced to paraphrasing and citations while continuing to practice summarizing skills. Students will continue to develop and practice grammar, punctuation, vocabulary, spelling and more complex sentence structures. Students will continue to gain confidence in their writing by planning, revising and editing their work. By the end of the course, students will be able to write a reflection essay and a three-page, double-spaced cause and effect essay.

- **Writing Learning Outcomes -** Students will be able to:
 1. produce a well-constructed and well-supported 5 paragraph timed essay
 2. produce summaries and paraphrases
 3. compose a two-page reflection

4. produce a three-page, typed, double-spaced, cause and effect essay
5. demonstrate an understanding of how to avoid plagiarism
6. compose a professional email for academic purposes

- 25% Reading Assignments, Summaries & Paraphrases
- 15% Reflection Essay
- 25% Cause/Effect Essay
- 25% Timed In-Class Final

Rules/Policies

Final Timed Writing: A final timed-writing will be worth 25% of your grade, and you will write it in class. You will have 50 minutes to brainstorm, outline and write your paper. You will not know the topic in advance. You will know the topic you need to write about on the same day of the final. You will not be allowed to use a dictionary for this final paper.

Extra Credit: ESL Center policy states that there are no extra credit assignments. There may be opportunities for extra credit on tests or quizzes.
