Notes: *For FY 2017, programs were only held accountable to achieving the Measurable Skill Gain (MSG) target of 63%. MSG is achieved by participants who achieve a recognized secondary credential, or complete an educational functioning level through pre-/posttest, or exit the program and enroll in postsecondary education and training during the program year. Employment and credential measures will be partially or fully accountable for reporting in FY 2018. All measures will have full accountability for reporting in FY 2019.

**The MSG target of 63% was negotiated with the federal Office of Career Technical and Adult Education on meeting the estimated minimum performance levels of the 12 Educational Functioning Level (EFL), which is one third of the way to meet the measurable skill gain performance measure. If the 63% MSG target is not met through EFL level completion, participants enrolling in postsecondary education and training or obtaining a recognized secondary credential during the program year can help with meeting the MSG target of 63%.
