Overview

Pertinent to Ohio Revised Code 3333.16 (C), this committee will coordinate the development and implementation processes for new statewide guaranteed transfer pathways, in collaboration with statewide faculty panels and other key stakeholders. This will enable students of Ohio public institutions of higher education to have a roadmap in their planning of academic and career goals. In addition, their successfully completed prior college-level work will transfer and apply toward a four-year degree program without unnecessary duplication of course work. Furthermore, through the committee work, Ohio will be able to offer consistent transfer pathways among its public institutions of higher education that yield (a) increased success after transfer, (b) a higher percentage of students completing an associate degree or certificate prior to transfer, and (c) a higher percentage of students completing a baccalaureate degree within four years after transfer.

Preliminary Statement of Work

- 1) Support the work of the faculty.
- 2) Monitor the progress in each academic cluster area based on the agreed-upon timeline.
- 3) Monitor the approval/endorsement progress of the Guaranteed Transfer Pathways.
- 4) Discuss, share, and help resolve any challenges that arise.
- 5) Develop and propose a policy to the OATN Oversight Board that guides the development and implementation of the newly created Guaranteed Transfer Pathways.
- 6) Discuss and suggest the language change to the legislation (ORC 3333.16(C)) as needed to the Ohio Department of Higher Education.
- 7) Work with the Transfer Practice Advisory Committee (Academic Transfer Support Services) on the implementation of the transfer pathways through advising and sound institutional processes.
- 8) Report progress to the OATN Oversight Board.
